The Chairman welcomed everyone to the meeting and advised that the meeting is being recorded.

A motion to suspend Standing Orders was proposed by Cllr Hasler, seconded by Cllr Buchanan and all voted in favour. The Chairman invited the Borough Councillors, County Councillor, and Community Warden to speak. Questions were also invited from the members of public.

County Cllr Sweetland spoke on the KCC budget for 2017-18 and his recent visits to the Meopham Baptist Church and the new Meopham Library site. Cllr Luxford asked for an update on the Lower Thames Crossing. Cllr Sweetland reported that the situation has not changed for a long time and is not sure when we can expect a decision.
